Unit shall have a uniquely designed, two-piece contoured bowls with P-traps integral to the unit. 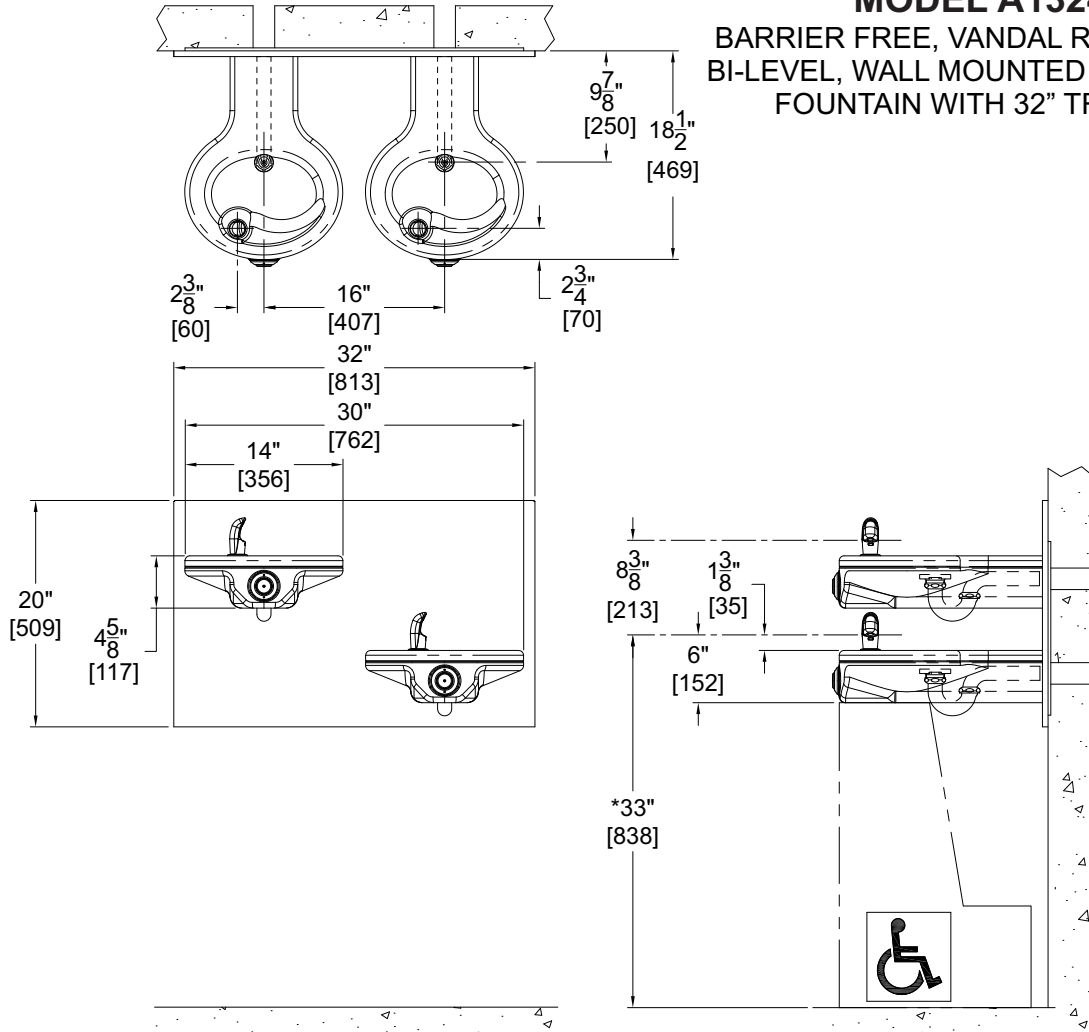
