


## OVERFLOW DRAIN WITH STANDPIPE AND OPTIONAL DOME FOR MEMBRANE FLOOR AREAS

**Specification:** MIFAB® Series F1100-C-W(D) lacquered cast iron floor drain with anchor flange, cast iron membrane clamp ring with primary and secondary weepholes for waterproofing membrane, adjustable 4" (102) diameter ABS standpipe and stainless steel dome. (For non-membrane floors, use MIFAB F1100-W(D) Series.)

**Function:** Used in an overflow drain in decorative fountains, pools, fish ponds and other similar areas. The dome assembled to the top of the standpipe prevents floating debris from entering the drain line. Membrane clamp is provided to secure the waterproofing membrane.
